TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Pauline LaFoy

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and No/100

DOLLARS (\$ 5000.00 ),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$50.00 on January 5, 1952, and a like payment of \$50.00 on the 5th day of each month thereafter until paid in full, said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed semi-annually and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on Callahan Avenue between Merrilat Avenue and Lenore Avenue, in Sans Souci Heights, a subdivision situate on the New Buncombe Road about four miles north of the City of Greenville, said lot having the following lines, courses and distances:

"BEGINNING at an iron pin on the Eastern edge of a 3 foot sidewalk running along Callahan Avenue, said pin being the joint corner of lots 131 and 132, thence along the eastern edge of said sidewalk, N. 27-55 E. 124.6 feet, to an iron pin, joint front corner of lots 132 and 133; thence along the southern line of lot 133, S. 74-15 E. 136.7 feet to an iron pin, rear corner of lots 132 and 133; thence along the rear lines of lots 128, 129, 130 and 131, S. 70-18 W. 203 feet to an iron pin, the beginning corner. Said lot being known and designated as lot No. 132, on plat of said property recorded in the R.M.C. Office for Greenville County, in Plat Book Z at Page 95."
