KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One (\$1.00) dollar and other considerations ----- Dollars, receipt whereof is hereby acknowledged, The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from ----- Clayton D. Cantrell -----

to The Federal Land Bank of Columbia, securing the payment of the principal sum of Twenty-nine hundred ----- (\$ 2900.00 ) Dollars, dated the 19 day of February 19 47 , and recorded in the public records of ----- Greenville ----- County, State of ----- South Carolina ----- in Mortgage Book ----- 359 -----, at page -174-----, the following described property, to-wit:

All that certain lot, piece or parcel of land situated, lying and being in Dunklin Township, County of Greenville, State of South Carolina, containing two and nine-tenths (2.9) acres, more or less, located on Highway No. 23-50 about two miles west of U. S. Highway No. 25, described as follows: BEGINNING at the southeast corner of the lot conveyed herein in the center of the road and running thence South 82 degrees, 30 minutes West three hundred forty-six and six tenths (346.6) feet to a stone XN; thence North 3 degrees West three hundred forty-nine and five-tenths (349.5) feet to a stone XO on the line of F. D. Cox; thence North 85 degrees East four hundred thirty and eight-tenths (430.8) feet to the center of the road; thence along the center of said road South 19 degrees 35 minutes West two hundred sixteen and six-tenths (216.6) feet to angle in said road; thence South 1 degree, fifty minutes East one hundred thirty-five and six-tenths (135.6) feet to the point of beginning, as will more fully appear by reference to plat of same by Thomas J. Leslie, Reg. Surveyor, by F. E. M. dated July 23, 1951, said lot being bounded on the North by lands of F. D. Cox, on the East by lands of Dr. J. P. Knight, road intervening, and on the South and West by lands of Clayton D. Cantrell, same being a portion of a tract of land conveyed by that certain deed dated February 21, 1947, of record in the office of R. M. C. for Greenville County, South Carolina, in Volume 308, at page 32.
