\$75.00 on the 15th day of each and every month hereafter commencing March 15, 1952. Payments to be applied first to interest, balance to principal, with the privilege to anticipate any part or all at any time,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Clyde Lamp and Dorothy K. Lamp in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy F. Haws and Vera H. Haws, their heirs and assigns forever:

All that piece, parcel or lot of land in Gantt Township about  $6\frac{1}{2}$  miles South of the City of Greenville, County of Greenville, State of South Carolina, on the East side of Augusta Road and being known and designated as Lot No. 31 on Plat of property of Albert Q. Taylor by Dalton & Neves, Engineers, dated May, 1946, and recorded in Plat Book P, page 49, R.M.C. Office for Greenville County, S.C., and having the following metes and bounds:
