I, William A. Henson

SEND GREETING:

Whereas, I, the said William A. Henson

in and by a certain note in writing, of even date with these

Presents, am well and truly indebted to The Commercial National Bank of Spartanburg

in the full and just sum of two thousand dollars (\$2,000.00)

to be paid in sixty equal and consecutive monthly installments of \$38.67 each, the first installment to be payable one month from date and to be continuous thereafter until the full amount has been paid

with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear
