interest, balance to principal,

with interest from date at the rate of six (6%) per centum per annum
until paid; interest to be computed and paid monthly and if unpaid when due to
bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceed-
ings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we , the said T. A. Norris and Bernice H. Norris

in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also
in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the
sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained,
sold and released, and by these presents do grant, bargain, sell and release unto the said First National
Bank of Greenville, S. C., as Trustee for Hillcrest Memorial Park
Perpetual Upkeep Fund, its successors and assigns, forever:

All that piece, parcel or lot of land near the City of
Greenville, Greenville Township, Greenville County, State of
South Carolina, in Elizabeth Heights and being known and
designated as Lot No. 56 on Plat recorded in Plat Book F,
page 298 and having the following metes and bounds, to-wit:

BEGINNING at a point on the West side of Chandler Street,
50 feet south of intersection of Chandler and Martin Streets,
corner Lots Nos. 56 and 57; thence with joint line of said
lots in a Westerly direction 150 feet to a point in line of
Lot No. 48; thence with Lot No. 48 in a Southerly direction
50 feet to a point, joint rear corner Lots Nos. 55 and 56;
thence with joint line of said lots in an Easterly direction
150 feet to a point on the West side of Chandler Street; thence
with said Street in a Northerly direction, 50 feet to beginning.
