All that parcel or tract of land containing four and eighty-six hundredths (4.86) acres, more or less, lying and being in Chick Springs Township, Greenville County, South Carolina, lying on the south side of Galphin Drive and designated as lots 2 through 12 on a plat of property of E. Greer, prepared by Dalton and Neves, Engineers, dated June, 1951, and amended August, 1952, and described as follows: BEGINNING at the east intersection of Galphin Drive and an unnamed street (the west corner of lot 1) and run along the southeast side of said drive North 35 degrees 54 minutes East 110 feet to the point of beginning, thence continuing along said drive North 35 degrees 54 minutes East 100 feet; North 44 degrees 52 minutes East 259.2 feet; North 62 degrees 24 minutes East 117 feet; North 75 degrees 27 minutes East 120 feet; North 80 degrees 05 minutes East 200 feet to an iron on the west side of a 40 foot road; thence, along west side of said road South 26 degrees 36 minutes East 200 feet to an iron; thence, South 80 degrees 05 minutes West 200 feet to an iron; thence, South 41 degrees 23 minutes West 91.3 feet to an iron; thence, South 32 degrees 48 minutes West 416 feet; South 76 degrees 15 minutes West 36.5 feet; North 60 degrees 18 minutes West 152.5 feet to iron; thence, North 35 degrees 54 minutes East 89.8 feet to an iron; thence, North 54 degrees 06 minutes West 185 feet to the point of beginning.
