# MORTGAGE

Greenville, S.C. , hereinafter called the Mortgagor, send(s) greetings: of

WHEREAS, the Mortgagor is well and truly indebted unto

Fidelity Federal Savings & Loan Association

, a corporation  
organized and existing under the laws of South Carolina , hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Fifty-Six and No/100- - -  
Dollars (\$ 5600.00 ), with interest from date at the rate of Four & One-Fourth per centum  
( 4 1/4 % ) per annum until paid, said principal and interest being payable at the office of Fidelity  
Federal Savings & Loan Association in Greenville, S. C. ,  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Thirty-Four and 72/100- - - - Dollars (\$ 34.72 ),  
commencing on the first day of October , 19 52 , and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of September , 19 72.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville ,  
State of South Carolina: on the Western side of Melville Avenue, in the City of  
Greenville, being shown as lot 24 on plat of Aberdeen Highlands, recorded in Plat  
Book M at Page 37, and described as follows:

BEGINNING at a stake on the Western side of Melville Avenue, at corner  
of lot 23, and running thence with the line of said lot, N. 39-43 W. 203 feet to  
a stake; thence N. 21-31 E. 62.2 feet to a stake at corner of lot 25; thence with  
the line of said lot, S. 42-55 E. 174.4 feet to a stake on Melville Avenue; thence  
with the Western side of Melville Avenue, S. 29-55 W. 80 feet to the beginning  
corner.
