I, **H. E. Hembree** (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All these certain pieces parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 60 of Block F and Lot No. 74 of Block D, as shown on Plat of University Heights, recorded in Plat Book BB at Page 21, and described as follows:

LOT NO. 60, BLOCK F:

BEGINNING at an iron pin at the Southwestern intersection of Corinne Drive and Carmel Street, and running thence with Carmel Street, S. 62-05 W. 110.9 feet to an iron pin, corner of Lot No. 75; thence with the line of said lot, S. 31-13 E. 190.3 feet to an iron pin, rear line of Lot No. 52; thence with the rear line of said lot and Lot No. 53, N. 56-37 E. 110.3 feet to an iron pin in the Western side of Corinne Drive; thence with said Drive, N. 31-13 W. 185 feet to the point of beginning.
