The Mortgagor herein hereby reserves the right to pay all, or any part, of the unpaid balance at any future installment paying period,

, with interest thereon from date

at the rate of five per centum per annum, to be computed and paid quarterly, on installment payment dates, until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

its successors and assigns: all that tract or lot of land in

Butler Township, Greenville County, State of South Carolina.  
and being known and designated as Lots Numbers 31, 32, 33 and 34 of a subdivision known as East Lynne, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "H" at page 195, and having in the aggregate, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southwest corner of the intersection of Lindsay Avenue with Lowndes Hill or Air Port Road, and running thence along the line of Lindsay Avenue, S. 9-14 E. 165 feet to an iron pin; thence S. 80-02 W. 100 feet to an iron pin, joint rear corner of Lots 30 and 31; thence along the joint line of Lots 30 and 31, N. 9-14 W. 164.4 feet to the joint corner of said lots on the South side of Lowndes Hill Road; thence along the line of said road, N. 80-43 E. 100 feet to the beginning corner.
