TO ALL WHOM THESE PRESENTS MAY CONCERN:

Greenville Home Builders, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto H. C. Smith and C. S. Fox

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Nineteen Hundred Fifty and 00/100

DOLLARS (\$1950.00),

with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: On or before six months after date, with interest thereon from date at the rate of Five per cent, per annum, to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Stephens Lane, in the City of Greenville, being shown as lot 114, on plat of property of Central Development Corporation, recorded in Plat Book BB at Pages 22 and 23, and described as follows:

"BEGINNING at a stake on the Eastern side of Stephens Lane, at corner of lot 113, and running thence with line of lots 113 and 129, N. 28-10 E. 166.4 feet to a stake; thence continuing with line of lots 128 and 127, N. 21-40 E. 100 feet to a stake at corner of lot 124; thence with line of said lot, N. 73-02 W. 75 feet to a stake at corner of lot 115; thence with line of said lot, S. 27-22 W. 203.8 feet to a stake on Stephens Lane, ^{thence with the eastern side of Stephens Lane,} S. 31-48 E. 91.7 feet to the beginning corner."

It is understood and agreed that this Mortgage is junior in lien to a mortgage this day executed by the mortgagor to Citizens Lumber Company in the sum of \$10,000.00.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
