porated herein by reference, in the principal sum of - - -Six Thousand and No/100- - - - -
Dollars (\$6000.00), with interest from date at the rate of
four per centum (4 %) per annum until paid, said principal and interest being payable
at the office of Goodyear Mortgage Corporation
in Charlotte, North Carolina, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of
- - - -Thirty One and 68/100- - - - - Dollars (\$ 31.68), commencing on the first day of
March, 19 53, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of February, 19 78.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina; all that piece, parcel or lot of land with the buildings and
improvements thereon, situate, lying and being near the City of Greenville, in the
County of Greenville, State of South Carolina, being known and designated as Lot
No. 19, Air Base Highlands, as per plat thereof recorded in the R. M. C. Office for
Greenville County, South Carolina, in Plat Book Z, page 195; said lot having a front-
age of 50 feet on the South side of Ace Avenue, a depth of 150 feet on the East, a
depth of 150 feet on the West and 50 feet across the rear.

The party of the first part covenants and agrees that so long as this
Mortgage and the said note secured hereby are insured under the pro-
visions of the National Housing Act, he will not execute or file for
record any instrument which imposes a restriction upon the sale or
occupancy of the mortgaged property on the basis of race, color, or
creed. Upon any violation of this undertaking, the party of the third
part, may, at its option, declare the unpaid balance of the debt secured
hereby immediately due and payable.

to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that
the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all

the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty
