(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Five Hundred and No/100- - - - DOLLARS (\$ 5500.00), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as ^{a part} lot No. 2 of a subdivision known as University Circle, a pkt of which is of record in the R.M.C. Office for Greenville County in Plat Book Y at Page 111, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the Northern side of Campbell Street, at the joint front corner of lots 1 and 2, and running thence N. 18-06 W. 136.9 feet to a point at the joint rear corner of lots ~~1~~ 1 and 2; thence N. 85-15 W. 70 feet to a point at the joint rear corner of lots 2 and 3; thence S. 23-10 E. 158.3 feet to a point on the Northern side of Campbell Street at the joint front corner of lots 2 and 3; thence with the Northern side of Campbell Street, N. 83-30 E. 70 feet to the point of beginning."
