WHEREAS, the Mortgagor is well and truly indebted unto

Fidelity Federal Savings & Loan Association

organized and existing under the laws of United States of America, a corporation
hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twelve Thousand and No/100 Dollars (\$ 12,000.00), with interest from date at the rate of Four & One-Fourth per centum (4 1/4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, S.C. or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-Four and 40/100 - - - Dollars (\$74.40), commencing on the first day of May, 19 53, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 19 73.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina: at the Southwest corner of Buena Vista Avenue and Midland Street, in the City of Greenville, being shown as lot 25, Block B, on plat of University Heights, recorded in Plat Book Y at Page 53, and described as follows:

BEGINNING at a stake at the Southwest corner of Buena Vista Avenue and Midland Street, and running thence with the Western side of Midland Street, the chord of which is S. 12-15 W. 299.7 feet to a stake at corner of lot 24; thence with line of said lot, N. 31-20 W. 203 feet to a stake on Buena Vista Avenue; thence with the Southeast side of said avenue, N. 58-10 E. 221 feet to the beginning corner. Being the same property conveyed to the mortgagor by Greenville Home Builders, Inc. by deed recorded in Volume 438 at Page 221.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
