TO ALL WHOM THESE PRESENTS MAY CONCERN: I, **Marvin H. Boling, same as M. H. Boling** of **Greenville, South Carolina**, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

All those pieces, parcels or lots of land, situate, lying and being near the City of **Greenville** in the County of **Greenville**, State of **South Carolina**, being known and designated as **Lots 80, 81 and 82**, plat of **City View Annex**, as per plat thereof recorded in the **R.M.C.
