at the rate of 6 per centum per annum, to be computed and paid quarterly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, or lot of land in Highland Township, Greenville County, State of South Carolina having the following metes and bounds.

BEGINNING on a stake in the road on the southern corner; thence S. 79 E. 1019 feet to a stake in the Wilson pasture; thence N. 20 E. 105 feet to the road center; thence with the road the line N. 66 W. 673 feet to a point in road center; thence S. 30 W. 150 feet to an iron pin; thence N. 66-45 W. 285 feet to a stake in road; thence S. 31 W. 175 feet to the beginning corner, containing 3.60 acres, more or less.
