To All Whom These Presents May Concern:

I, Jack Charles Campbell, Jr. - - - - - SEND GREETING:

WHEREAS, I the said Jack Charles Campbell, Jr.

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Three Hundred & no/100 - - - - - (\$ 300.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Four & 80/100 - - - - - (\$ 4.80) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said Jack Charles Campbell, Jr.

, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township and more fully described as follows:-

BEGINNING at a point in the road known as the Chandler Road (and on the line of H. P. Beam) which leads from the Augusta Road to Pelzer and running thence along said road S. 75-40 W. 416.4 feet to a corner in said road; thence leaving said road and running by a new line N. 1-35 W. 500 feet to a stake; thence N. 24-50 E. 655 feet to a point in an old road on line of T. M. Fennells land; thence with his line S. 64 E. 342 feet to a stake; at Grove Creek at corner of H. P. Beams land; thence with Beams line S. 20 W. 578 feet to a stake; thence S. 48 W 178 feet to the beginning corner, and containing 8.04 acres, more or less, and being a part of the same land conveyed to H. Greely Stanton by Deed of T. M. Fennell October 22nd, 1943, and recorded in R. M. C. Office for Greenville County in Vol. 258, page 66, and conveyed to Otto Shirley by Deed by H. Greely Stanton January 13th, 1948, said deed of record in R. M. C. Office for Greenville County in Vol. 333, page 177.

This is the same lot of land conveyed to me by Otto Shirley by Deed dated April 7, 1952, recorded in R. M. C. Office for Greenville County.
