TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. R. Cordell--- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Ross Builders Supply, Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Hundred and no/100---

----- December 1, 1953 DOLLARS (\$1500.00),
with interest thereon from ~~date~~ at the rate of 6 per centum per annum, said principal and interest to be repaid: 90 Days after date, with interest thereon from December 1, 1953, at the rate of six per cent per annum, to be computed and paid at maturity.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Anchorage Avenue, in the City of Greenville, being shown as lot 14, on plat of the Davis property, recorded in Plat Book AA at Page 123, and described as follows:

"BEGINNING at a stake on the Eastern side of Anchorage Avenue, 360 feet South from Haviland Avenue at the corner of lot 13; running thence with the line of said lot N 55-09 E. 155.9 feet to a stake at the corner of lot 6; thence with the line of said lot, S. 41-29 E 77.3 feet to a stake at the corner of lot 15; thence with the line of said lot, S 56-01 W. 176.2 feet to a stake on Anchorage Avenue; thence with the Eastern side of Anchorage Avenue, N. 26-15 W. 75 feet to the beginning corner."

Being the same property conveyed to the mortgagor by deed recorded in Book of Deeds 480 at Page 499.

It is understood and agreed that the lien of this mortgage is junior to the lien of the mortgage executed by mortgagor to Fidelity Federal Service and Loan Association recorded in mortgage book 570, page 381.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
