TO ALL WHOM THESE PRESENTS MAY CONCERN: LAURA GIVENS AND LUCILLE GIVENS DAVIS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of FIFTEEN HUNDRED AND NO/100 - - - - -

DOLLARS (\$ 1,500.00 ), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of North Avondale Avenue, formerly Maple Avenue in the City of Greenville, being shown as all of Lot No. 10 and Southern half of Lot No. 9 as shown on Block F of Plat of J. A. and P.F. Cureton and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Avondale Avenue at the joint front corner of Lots 10 and 11 and running thence with line of Lot No. 11 S. 86-14 E. 109.9 feet to iron pin; thence N. 2-20 E. 112.5 feet to iron pin in the center of rear line of Lot 9; thence with line of Lot 9 N. 86-13 W. 118.5 feet to pin on Avondale Avenue; thence with the Eastern side of Avondale Avenue N 00-43 W. 112.5 feet to the point of beginning.

Said premises being the same conveyed to Morris/Givens and Laura Givens by two separate deed recorded in Volumes 271 at Page 279 and 272 at Page 194.

Morris B. Givens died in 1946, leaving his widow, Laura Givens and one daughter Lucille Givens Davis.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
