SEND GREETING:

Whereas, We the said George Alvin Williams and Frances Vivian Williams, in and by Our certain Promissary note in writing, of even date with these Presents, are well and truly indebted to Lyman Bryson

in the full and just sum of Three Hundred Fifty & No/100 Dollars (\$ 350.00), to be paid One year after date.

, with interest thereon from Date at the rate of 1% per centum per annum, to be computed and paid Annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Lyman Bryson.

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing Two Acres (2) more or less, adjoining lands of Pearl M Osteen, J.R.Bishop, J.W.Brock and possibly others, having the following courses and distances to wit ;

BEGINNING at a stake at corner of Mrs. Pearl Osteen, running thence South 68-1/2- West, 404.5 feet to a stake ; thence North 49- West, 257.4 feet to corner in old road ; thence North 42-West 205 feet to corner in branch near spring of Mrs. E.A.Cason ; thence along line of Mrs.E.A.Cason North 73-3/4 East to corner of J.R. Bishop; thence along line of J.R.Bishop South 10-1/2- E 86 feet to a stake ; thence South 23-1/2-East 110 feet to a stake, thence South 63-3/4- East 66 feet to a stake ; thence South 83 East, 188 feet to a stake, new corner ; thence southerly to beginning corner.
