SEND GREETING:

Whereas, I, the said H. E. Barbrey  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to Farmers Bank of Simpsonville  
in the full and just sum of Seventeen Hundred and No/100 --- Dollars  
to be paid six months after date

with interest thereon from date  
at the rate of 6 per centum per annum, to be computed and paid semi-annually, in  
advance until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the

All that certain piece parcel or lot of land, lying and being in  
Austin Township, Greenville County State of South Carolina, on the  
south side of Trade Street in the Town of Simpsonville and being  
a portion of a larger lot of land conveyed to Leola Cox by L. S.  
Verdin by deed dated January 4, 1945, recorded in Deed Book 270,  
page 433, R. M. C. Office for Greenville County, and being more  
specifically described on a plat thereof made by E. E. Gary,  
Surveyor on April 25, 1947. According to the Gary Plat the lot  
begins at an iron pin on the south side of Trade Street and runs  
thence N. 72 E. 48 ft. to iron pin; thence S. 8 1/2 E. 177 ft.  
to iron pin; thence S. 67 1/4 W. 60 ft. to iron pin; thence  
N. 4 3/4 W. 181 1/2 ft. to the iron pin at the beginning corner,  
and being the same lot conveyed to H. E. Barbrey by Leola Cox by  
deed dated May 12, 1947, recorded in Vol. 312, page 75, R. M. C.  
Office for Greenville County.
