in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also
in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the
sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained,
sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina
National Bank, Greenville, S. C., Trustee under Agreement with Nelson B.
Arrington, its successors and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina,
situate, lying and being in the City of Greenville on the western side of Stone Avenue
ByPass and having, according to a plat of Property of James D. Shives by Dalton
& Neves, Engineers dated February, 1954, and recorded in the R. M. C. Office
for Greenville County in Plat Book X, page 156, the following metes and bounds,
to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of
Stone Avenue ByPass and Hilly Street and running thence with the western side
of said ByPass N. 12-49 E. 61.1 feet to an iron pin; thence with other property of
the Grantor N. 75-49 W. 50.9 feet to an iron pin; thence still with other property
of the Grantor S. 21-44 W. 22.3 feet to an iron pin at the corner of property here-
tofore conveyed by the City of Greenville to the Grantee herein; thence with the
line of that property, S. 40-30 E. 67.8 feet to the beginning corner.
