called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Nine Thousand, Nine Hundred Fifty and No/100** - - - - - Dollars (\$9,950.00), with interest from date at the rate of **Four & One-Half** per centum (4½ %) per annum until paid, said principal and interest being payable at the office of **CANAL INSURANCE COMPANY** in **Greenville, South Carolina**, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Fifty-Five and 31/100** - - - - - Dollars (\$55.31), commencing on the first day of **July**, 19**54**, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **June**, 19**79**.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville** State of South Carolina;

All that lot of land, with the buildings and improvements thereon, situate on the northeast side of Blythwood Drive, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 25 on plat of University Circle, made by Piedmont Engineering Service, May 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Y", at Page 111, said lot fronting 70 feet along the northeast side of Blythwood Drive and running back to a depth of 142.6 feet on the southeast side, to a depth of 137.3 feet on the northwest side and being 70.3 feet across the rear.

The above described property is the same conveyed to the mortgagor herein by deed of W. B. Hickman of even date and to be recorded herewith.
