

monthly until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Oneal Township, Greenville County, State of South Carolina, on the East side of Greenville Road, now known as the Sandy Flat Road, adjoining lands now or formerly of the Crumley estate on the North, Bradley on the West, and Glenn on the South and East and being more fully described as follows:

BEGINNING at an iron pin on the Crumley line and Bradley's corner and being the old roadbed of the Greenville Road, and runs thence with the said Old Road S. 24-53 W. 176.5 feet to an iron pin in the Old Road; thence S. 13-20 W. 137 feet to an iron pin in the Old Road; thence N. 83-37 E. 1195 feet to an iron pin in branch 3xnm; thence down the general direction N. 14-54 E. 247 feet to an iron pin; thence N. 0-00 E. 204.5 feet to a fence post by White Oak Stump, Crumley's corner; thence with Crumley line S. 78-30 W. 520 feet to an iron pin; thence S. 75-50 W. 660 feet to the beginning corner, containing 10 acres, more or less

This is a second mortgage, being junior only to a mortgage executed by Clyde C. Jones to Fidelity Federal Savings and Loan Association. This is a purchase money mortgage being given to secure the credit portion of the purchase price.
