NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southwest side of Cox Bridge Road, sometimes referred to as Pendleton Road and Saluda Dam Road, and being known and designated as Lot No. 3, of the property of H. J. Martin as shown on plat recorded in Plat Book H, page 53, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the joint corner of Lots Nos. 2 and 3, and running thence along the joint line of said lots, S. 34 W. 177.5 feet to an iron pin in line of the property of the Southern Cotton Oil Mill, and running thence along the line of that property, N. 76-26 E. 75 feet, more or less, to an iron pin at joint rear corner of Lots Nos. 3 and 3B; thence along the joint line of said lots, N. 34 E. 125 feet, more or less, to an iron pin on the southwest side of Cox Bridge Road; thence along the line of said Road, N. 56 W. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty."

The above described property is the same conveyed to C. L. Tinsley and Cora V. Tinsley by Mary C. Vaughan and Lucy C. Vaughan by deed dated August 31, 1946 and recorded in the R. M. C. office for Greenville County in Vol. 298, at page 158, the said C. L. Tinsley having died on December 31, 1950, leaving a will whereunder he devised the above described property to the mortgagor herein. Said will is on file in the office of the Probate Judge for Greenville County in Apt. 597, File 32.
