All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the southeastern side of Pitts Street as shown on a plat of the property of Talmer Cordell made by Dalton & Neves in April, 1951, recorded in Plat Book An, Page 33, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeastern side of Pitts Street which pin is 209.7 feet northeast from the intersection of Pitts Street and Hampton Circle at the joint front corner of Lots 18 and 19 and running thence with joint line of said lots S. 47-00 E. 205 feet to an iron pin in the northwest side of Hampton Circle; thence with said Circle N. 43-00 E. 85 feet to an iron pin rear corner of Lot 17; thence with line of said lot N. 47-00 W. 205 feet to an iron pin in the southeast side of Pitts street; thence with said street S. 43-00 W. 85 feet to the point of beginning."
