"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs,

Township, on the north side of Maryland Avenue in the City of Greer, known and designated as lot No. 55 on plat of Development #2 of the Victor-Monaghan Co., Division of J. P. Stevens & Co., Inc., Greer Mill Plant, prepared by Dalton & Neves, Engineers, April 1947, and recorded in R. M. C. Office for this County in Plat Book P at page 119, and having according to said plat the following courses and distances to wit:-
