"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the south side of the Brushy Creek Road in the City of Greer, designated as Lot No. 13 of the Property of the Mrs. E.A.
