M. C. office for Greenville County in Plat Book S, at page 103, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the northeastern corner of the intersection of Morningside Drive and Milton Drive, and running thence with the eastern side of Morningside Drive, N. 0-18 E. 130.75 feet to an iron pin; thence N. 84-24 E. 116.4 feet to an iron pin in the rear line of Lot No. 68; thence on a line through Lot No. 68, S. 4-26 E. 150.127 feet to an iron pin on the northern side of Milton Drive; thence with the northern side of Milton Drive, S. 84-24 W. 107.9 feet to an iron pin; thence with the curvature of the intersection of Milton Drive with Morningside Drive, the chord of which is N. 47-32 W., 26.9 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
