"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being lot No. 14 of Block F, as slown on a plat of Fair Heights recorded in the Block Confice for Greenville County in Plat Book F at Page 257, and being more carticularly described according to a recent survey of Fiedmont Engineering Service as follows:

"BEGINNING at an iron pin on the Southeast side of Brookdale Avenue, which is 250 feet from the intersection of Brookdale Avenue and Hanover Street, and is absoluted joint front corner of lots Nos. 14 and 15, and running thence with joint line of with lots, S. 58-40 E. 150 feet to an iron pin in rear line of lot No. 6: thence with line of said lot, S. 31-20 W. 50 feet to iron pin, joint rear corner of loss 13 and 10: thence with joint line of said lots, N. 58-40 W. 150 foot to an iron rise or the Continues side of Brookdale Avenue: thence with said Avenue, N. 31-20 W. 5 foot to the release of beginning."
