To All Whom These Presents May Concern:
I, David U. Mauldin, of Greenville County,
SEND GREETING
WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date we these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREE
VILLE, in the full and just sum of Ten Thousand and No/100
(\$ 10,000.00) Dollars, with interest at the rate specified in said note, to be repaid in installments
One Hundred and No/100 (\$ 100.00 Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal su with interest has been paid, said monthly payments shall be applied first to the payment of interest, comput monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any tir any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) day or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, to whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payabe who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); in and by said note, reference being thereunto had, will more fully appear.
NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of mone aforesaid, and for the better securing the research of the said debt and sum of mone aforesaid.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN of Three Dollars to me/us the said mortgagor(s) in terms of said note, and also in consideration of the further sum INGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt gain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, being known and designated as a portion of Lots Nos. I and 2 of the property of Sumlar Hall in a section known as Nicholtown, as shown on a plat thereof prepared by Pickell & Pickell, Engineers, on September 18, 1953, not yet recorded, said lots being a portion of Tract No. 5 of the property of the Estate of James Hall as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book C, at page 89, and being known and designated as Lots Nos. 1 and 2 on a plat of the property of D. U. Mauldin as made by C. C. Jones, C. E., on Aug. 4, 1954, and having, according to the Jones plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Hall Street at the corner of Lot No. 3, which point is 59 feet East of the intersection of River Street, and running thence along the line of Lot No. 3, N. 22-38 W. 125.6 feet to an iron pin in line of Lot No. 3 of the Sumlar Hall property; thence along the line of that property, N. 67-22 E. 131.3 feet to an iron pin; thence S. 17-04 E. 126 feet to an iron pin on the north side of Hall Street; thence along the north side of Hall Street, S. 67-22 W. 119 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to me by Sumlar Hall by deed of even date herewith, not yet recorded."
