C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor—in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, School District 9-I, near the northern limits of Greer and designated as Lot #18 on plat of the property of B. W. Waters and having the following courses and distances to wit:-

BEGINNING at the joint corner of lots #17 and 18 on the eastern edge of a new 30 foot road, and runs thence as the dividing line between said lots, N 78-43 E. one hundred seventy-three and five tenths (173.5) feet to stone, old corner at .940 on Arthur Zimmerman line, thence with his line S. 10-02 E. one hundred (100) feet to iron pin; thence S. 78-43 W. one hundred seventy-two (172.5) feet to edge of said road; thence therewith N. 10-02 W. one hundred (100) feet to the beginning corner.
