(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Independent Life & Accident Inquance Company, a Florida Corporation (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ninety-Two Hundred and No/100

DOLLARS (\$9200.00),

with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: At the office of the payee in Jacksonville, Florida, or at such other place as may be designated by the holder hereof in monthly installments of \$72.76 each, payable respectively on the 13th day of September next hereafter and on the same day in each succeeding month until paid in full, said payments to be first arrived in payment of monthly interest and the balance thereof upon and in reduction of principal, with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid monthly, until paid in full, all principal and interest not paid when due to bear interest at the rate of 7% per annum.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot #81, as shown on plat #2 of Sunset Hills, recorded in Plat Book P at Page 19, and being more particularly described according to a recent survey prepared by C. C. Jones as follows:

"BEGINNING at an iron pin in the Southwest side of Sunset Drive, which pin is 300 feet from the Southwest intersection of Sunset Drive and Waccamaw Avenue, and is the joint fron corner of lots 80 and 81, and running thence with Sunset Drive, N. 41-10 W. 75 feet to iron pin, corner of lot 82; thence with line of said lot, S. 48-50 W. 175 feet to iron pin in the Northeastern side of a five foot strip r eserved for utilities; thence with said strip, S. 41-10 E. 75 feet to iron pin, rear corner of lot 80; thence with line of said lot, N. 48-50 E. 175 feet to the point of beginning."
