(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ONE THOUSAND

DOLLARS (\$ 1,000.00), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, sitiate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs, Township, about one mile West from the City of Green, lying on the South side of the U.S. Dual Lane Highway To. 29, being all of Indiana. 30 and 31 as shown on a plat of property made for the T.M. Dill Mattee by S.C. Moon, Surveyor, dated October 1940, which plat is an record in the R.M.C. Office for Greenville County. Each of said lets fromts 50 feet on the South side of said highway, has a mear with a 50 feet on the South of 200 feet, making a total from a little of 100 feet. Reference to said plat and record there are made for a complete and detailed description of said lets. This is a portion (Lot 32 excluded) of that property economic mortgagors by T.D. Elmore by deed dated Earch 11, 1921, according to R.M.C. Office for Greenville County in Doed Took 12.
