SEND GREETINGS:

WHEREAS,-I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Four Thousand, Three Hundred and No/100 - - - - -

(\$ 4,300.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the branch waters of Brushy Creek of Enoree River, containing 14.77 acres, more or less, and having, according to a plat of the property of Frances W. Burns, et al. prepared by J. Mac Richardson, L. S., September, 1953, the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the line of a telephone cable line, the joint corner of properties belonging to Clyde Ross and R. D. Julian, and running thence along the line of property of Clyde Ross, N. 10-00 W. 789.5 feet to an iron pin at the joint corner of Clyde Ross and Jesse James; thence along the line of Jesse James, N. 54-01 W. 887 feet to a point in a branch; thence up said branch, following the meanders thereof, the traverse line of which is S. 25-40 W. 229.6 feet to a point in said branch on the line of the Divver Estate; thence along the line of the Divver Estate, S. 62-30 E. 182 feet to an iron pin; thence continuing along the line of the Divver Estate, S. 29-00 W. 375 feet, more or less, to an iron pin at the corner of a lot heretofore conveyed to J. H. H. Tooley; thence along Tooley's line, S. 43-13 E. 176.9 feet to an iron pin at the corner of Rufus Tooley; thence along the line of Rufus Tooley, S. 85-10 E. 237.7 feet to an iron pin at the corner of Bruce Maloy; thence along Maloy's line, S. 83-35 E. 216.5 feet to an iron pin; thence continuing along Maloy's line, S. 8-25 W. 500 feet to an iron pin in line of Harold Robinson; thence along Robinson's line, S. 67-25 E. 97.8 feet to an iron pin; thence S. 2-44 E. 40.3 feet to an iron pin in line of Julian and the telephone cable line; thence along Julian's line, N. 79-25 E. 427 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same tract of land conveyed to us by Frances Ward Burns by deed of even date herewith, not yet recorded."
