NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of the Bent Bridge Road, being known and designated as lot No. 3 of Cordell Subdivision No. 10, as shown by a plat thereof made by C. C. Jones, Engr., December 1952, recorded in the R.M.C. Office for Greenville County in Plat Book BB at Page 84, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northern side of the Bent Bridge Road, corner of lot 4, and running thence with lot 4, N. 23-36 W. 206.7 feet to the rear corner of lots 3 and 4; line of E. B. Hinton; thence with the Hinton line, N. 84-10 E. 78.5 feet to the rear corner of lot 2; thence with the line of lot 2, S. 23-36 E. 183.1 feet to the Northern side of Bent Bridge Road; thence with the Northern side of Bent Bridge Road, S. 66-34 W. 75 feet to the beginning corner."
