NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the Southern side of South Rockview Drive, and being shown and designated as lot No. 9, on plat of the property of Joe A. Phillips, recorded in Plat Fook AA at Page 176, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin at the joint front corner of lots Nos. 9 and 11, and running thence with line of lot No. 11, S. 18-56 E. 166.5 feet to iron pin in line of Hill property; thence with line of Hill property, S. 79 W. 126.3 feet to pin at rear corner of lot 7; thence with line of lot 7, N. 18-50 W. 156.8 feet to pin on Southarn side of South Rockview Drive; thence with the Southern side of said Drive, N. 74 F. 126 feet to the point of beginning."
