C. Jones, C. E., April, 1954, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Cool Brook Drive, joint front corner of Lots 55 and 56, and running thence with the joint line of said lots, S. 64-26 W. 156 feet to an iron pin in the center of a branch, joint rear corner of Lots 55 and 56; thence with the meanderings of said branch, the traverse line of which is S. 26-00 E. 70.2 feet to an iron pin in the center of said branch, joint rear corner of Lots 56 and 57; thence with the joint line of said lots, N. 64-26 E. 155 feet to an iron pin on Cool Brook Drive; thence with said drive, N. 24-34 W. 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
