All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, located about five miles North from Green and on the South side of the Gap Creek Road, bounded on the North by said road, on the East by Dan L.Ray, Jr., on the South by lands of Dan L. Ray, Sr., and on the West by Melvin Wilson, having the following courses and distances:

BEGINNING at a point in the center of the Gap Creek Road, joint corner with Melvin Wilson's land, and runs thence with his line S. 20.45 W. 885 feet to a locust post; thence S. 82.15 E. 175 feet to an iron pin on the East side of branch and on line of W.W.
