WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Ninety-Five Hundred and No/100 - - - -**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as the southern portion of lot #4, of Block B as shown on plat of property of Alice H. and H. H. Willis, recorded in Plat Book J at Page 16, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the east side of Arch Street, which pin is 100 feet south of the intersection of Arch Street and McDowell Avenue, and running thence N. 60-30 E. 100 feet to iron pin in line of lot 5; thence with line of said lot, S. 26-30 E. 144 feet to iron pin, rear corner of lot #1; thence with line of said lot, S. 77-10 W. 103.2 feet to iron pin in the east side of Arch Street; thence with said street, N. 26-30 W. 113 feet to the point of beginning."
