Whereas, we, the said Clarence and Leona Allen
in and by our certain promissory note in writing, of even date with these
Presents, we are well and truly indebted to Bank of Piedmont
in the full and just sum of (\$499.45) Four Hundred Ninety-nine and 45/100
, to be paid Payable one year from date

, with interest thereon from maturity
at the rate of 6 per centum per annum, to be computed and paid in advance
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, one lot of land lying and situated in the Rehobeth School District, State and county aforesaid, having the following courses and distances to wit:-

Beginning at iron pin in center of dirt road leading to the McJunkin property, thence N-64-00 W 100 feet to an angle thence N-20-00 W 38 feet to joint corner Grantor and Allen (new corner), thence N-48-45 E 82 feet- 67 inches to corner of Grantor, thence S-48-35 E 141 feet to a point in road, thence along said dirt road S-21-34 W 80 feet to the beginning corner.
