NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Cole Road, near the City of Greenville, being shown as lot # 110, on a plat # 4 of Camilla Park, recorded in the R.M.C. Office for Greenville County in Plat Book M at Page 117, and described as follows:

"BEGINNING at a stake on the Northern side of Cole Road, 159.6 feet East from the angle of Cole Road, at corner of lot 111, and running thence with the line of said lot, N. 2-09 E. 337.2 feet to a stake, corner of lot 113; thence with line of said lot, S. 88-49 E. 183.3 feet to a stake at corner of lot 109; thence with the line of said lot, S. 3-15 W. 342.2 feet to a stake on Cole Road; thence with the Northern side of Cole Road, N. 86-45 W. 151.5 feet to the beginning corner."

SUBJECT HOWEVER, to 50 feet of the right-of-way of Duke Power Company for a transmission line on the western line of said lot.
