MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I. J. M. Brown (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Shenandoah Life Insurance Company, Inc.**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Fifteen Thousand and No/100 - -**

DOLLARS (\$ 15,000.00),

with interest thereon from date at the rate of **Five (5%)** per centum per annum, said principal and interest to be repaid: **in monthly installments of Ninety-nine and No/100 (\$99.00) Dollars each, on the 5th day of each month hereafter, beginning December 5, 1954, to be applied first to accrued interest and then to principal until paid in full, and in any event, to be paid in full by November 5, 1974, with interest thereon from date at the rate of Five (5%) per cent. per annum, to be computed and paid monthly**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwest side of Lullwater Road in the City of Greenville, being shown as Lot No. 48 on a plat of Northside Gardens recorded in Plat Book "S" at Page 17, and described as follows:

"BEGINNING at a stake on the southwest side of Lullwater Road 770 feet northwest from E. North Street at corner of Lot 47 and running thence with the southwest side of Lullwater Road N. 37-13 W. 90 feet to a stake at corner of Lot 49; thence with the line of said lot S. 52-47 W. 238.1 feet to a stake; thence S. 33-41 E. 90.15 feet to a stake at corner of Lot 47; thence with the line of said lot N. 52-47 E. 243.7 feet to the beginning corner."

Being the same property conveyed to the mortgagor by R. M. Gaffney and C. E. Robinson, Jr., by deed recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
