To All Whom These Presents May Concern:

I, Aletha F. Hunter

SEND GREETINGS:

Whereas, I the said Aletha F. Hunter  
in and by certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to  
HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina,  
in the full and just sum of Three Thousand and No/100 Dollars,  
(\$ 3000.00 ) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum  
(6%) per annum, to be repaid in installments of Thirty and No/100 (\$30.00 )  
Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest  
has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and  
then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the  
option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's  
fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible  
as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected  
by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,  
reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I , the said Aletha F. Hunter

, in consideration of the said debt and sum of money  
aforesaid, and for the better securing the payment thereof to the said HOME BUILDING & LOAN ASSOCIATION, Easley, South  
Carolina, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me , the said  
Aletha F. Hunter

, in hand and truly paid by the said HOME BUILDING & LOAN ASSOCIATION, Easley,  
South Carolina, at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIA-  
TION, Easley, South Carolina, its successors or assigns:

All that lot of land in Grove Township, Greenville County, State of South Carolina,  
on the Southern side of Osteen Road, being shown as tract # 3, on plat of property of  
T. H. Hunter, et al, recorded in the R.M.C. Office for Greenville County in Plat Book  
FF at Page 155, and described as follows:

"BEGINNING at a stake on the Southern side of Osteen Road, at corner of Master's  
property and running thence with the line of said property, S. 31-45 E. 710 feet to a  
stake; thence N. 73-16 E. 204 feet to a stake; thence N. 24-12 W. 437 feet to a stake  
at corner of lot 2; thence with line of said lot, S. 72-09 W. 100 feet to a stake; thence  
with the line of said lot, N. 22-30 W. 109 feet to stake on Osteen Road; thence with  
the Southern side of said Road, N. 76-36 W. 284 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by Henry D. Vaughan by deed to  
be recorded.

signs, and every person whomsoever lawfully claiming or to claim the name or any part thereof.
