

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Three Thousand, Two Hundred and No/100 - - - -(\$3,200.00 - - ) Dollars, with interest at the rate specified in said note, to be repaid in installments of

"BEGINNING at an iron pin on the west side of bilbarn Avenue at the corner of Lot No. 70, which point is 115 feet north of the northwest corner of the intersection of Hill Street with said kilburn avenue, and running thence along the line of Lot No. 70, S. 85-56 W. 80. feet to an iron pin in line of the right-of-way of the . & N. Railway; thence along the line of said right-of-way, N. 9-42 W. 50.25 feet to an iron pin at the rear corner of Lot No. 72; thence along the line of said Lot No. 72 N. 35-56 E. 95.8 feet to an iron pin on the west side of Milburn Averue; thence along the line of said Wilburn Avenue, S. U-Ch E. 50 fect to the beginning corner, including the plumbing, heating, and electrical fixtures now located on said premises or to be installed thereof, which are hereby expressly agreed to be a part of the realty.
