Lot No. 63: BEGINNING at an iron pin at the northwest intersection of Frances Avenue and Beatrice Street, and running thence along the line of said Beatrice Street, N. 16-01 W. 68 feet to an iron pin at corner of Lot No. 62; thence along the line of Lot No. 62, S. 67-50 W. 192.5 feet to an iron pin on a 20-foot alley; thence with said alley, S. 18-32 E. 67.95 feet to an iron pin on Frances Avenue; thence with said Frances Avenue, N. 67-48 E. 189.5 feet to the beginning corner. Being the same lot of land conveyed to me by B. T. Gladden by deed dated September 9, 1939, and recorded in the R. M. C. office for Greenville County in Vol. 213, at page 386.

Lot No. 64: BEGINNING at an iron pin at the corner of Mary Street and Frances Avenue, and running thence along the eastern side of Mary Street, N. 18-09 W. 68 feet to an iron pin at the corner of Lot No. 65; thence with the line of Lot No. 65, N. 67-50 E. 189.6 feet to an iron pin on a 20-foot alley; thence along the line of said alley, S. 18-32 E. 67.95 feet to an iron pin on Frances Avenue; thence along the line of Frances Avenue, S. 67-48 W. 190 feet to the beginning corner. Being the same lot conveyed to me by B. C. Roberts by deed dated June 19, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 458, at page 67.
