NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs, Township, located within the incoporate limits of the City of Greer, and having the following courses and distances: BEGINNING at a stake on the Oscar B. Stokes line at corner of lot now or formerly owned by Dora Johnson; thence in a southerly direction 75 feet, more or less, to a stake on line of property now or formerly owned by Franklin Mills; thence in an easterly direction 85 feet, more or less, to a stake on an unnamed street, sometimes known as Franklin Street Extension; thence in a northerly direction 75 feet to a stake on line of the Dora Johnson lot; thence in a westerly direction 85½ feet, more or less, to the beginning corner, and being all of that lot of land conveyed to the mortgagor herein by James M.
