"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, being known and designated as Lots Nos. 43 and 44 of a subdivision known as Forest Park, north of the Town of Simpsonville, plat of said subdivision being recorded in Plat Book EE, pages 64 and 65, R. M. C. office for Greenville County, and being more fully described as follows:

"BEGINNING at an iron pin on northwest side of Gresham Park Drive, corner of Lot No. 42, and running thence along line of Lot No. 42, N. 41-30 W. 192.2 feet to iron pin; thence along line of Lots 37 and 35, N. 55-00 E. 180 feet to iron pin; thence along line of Lot No. 45, S. 41-30 E. 171.7 feet to iron pin on Gresham Park Drive; thence along said drive, S. 48-30 W. 178.8 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
