NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Toumship, on the western side of Flora Avenue, being known and designated as let No. 58 of Camilla Park Subdivision, according to plat #2 by W. J. Riddle in Becamber 1943, recorded in Plat Book M at Page 85, and described as follows:

"BEGINNING at am Iron pin at the southwestern intersection of Flora Avenue and Harvard Avenue, and running thence along the western side of Flora Avenue, S. 20-51 V. 81 feet to am iron pin at corner of let 57; thence along line of let 57, N. 60-51 W. 208 feet to an iron pin at rear joint corner of lots 10 and 11; thence along rear line of let 10, N. 27-40 E. 80.7 feet to am iron pin on the southern side of Harvard Avenue; thence along Harvard Avenue S. 60-51 E. 200 feet to the point of beginning."
