"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, in a subdivision of land known as Belmont Heights as shown on plat made by C.C. Jones, Engineer as Lot No. 66 on the southern side of Kay Drive, and having, according to said plat, the following metes and bounds, to-wit:

The deed from Local Home Builders, Inc. to Norman Hamilton, Jr. indicates that this lot has a uniform depth of 155 feet; however, a subsequent plat of this property shows that the correct depth of Lot No. 66 is 160 feet rather than 155 feet.
