TO ALL WHOM THESE PRESENTS MAY CONCERN: Edward C. McNeill

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighteen Thousand and no/100

DOLLARS (\$ 18,000.00), with interest thereon from date at the rate of five per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of McNeill Court being known and designated as Lot No. 16, according to plat of Wilton Oaks, made by Dalton and Neves, Engineers, dated June, 1952 of record in the R. M. C. Office for Greenville County in Plat Book "BB", at page 49 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of McNeill Court which iron pin is the joint front corner of Lots Nos. 16 and 15; running thence along the joint line of said lots, S. 0-55 W. 176.2 feet to an iron pin; running thence S. 79-15 E. 66 feet to an iron pin, joint rear corner of Lots Nos. 16 and 17; thence along the joint line of said last mentioned lots, N. 0-55 E. 187.6 feet to an iron pin on the southern side of McNeill Court, joint front corner of Lots Nos. 16 and 17; running thence along the southern side of McNeill Court, N. 89-05 W. 65 feet to the point of beginning.

ALSO, all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina on the southern side of McNeill Court, being known and designated as Lot No. 17, according to plat of Wilton Oaks, made by Dalton and Neves, Engineers, dated June, 1952 of record in the R. Beginning at an iron pin on the southern side of McNeill Court, joint front corner of Lots Nos. 17 and 16; thence along the joint line of said lots, S. 05-55 W. 177.6 feet to an iron pin; running thence S. 79-15 E. 66 feet to an iron pin, joint rear corner of Lots Nos. 17 and 20; running thence along the joint line of Lots Nos. 17 and 20, 19 and 18, N. 0-55 E. 189.0 feet to an iron pin on the southern side of McNeill Court; running thence along the southern side of McNeill Court, N. 89-05 W. 65 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
